1. About Financial Assistance

Parents and guardians who face financial difficulties sending their children to public elementary and/or junior high school may be eligible to receive financial assistance in relation to school supplies, school lunches, and other educational expenses.

2. Regarding Eligibility and Necessary Documentation

- Two copies per 1 child are required when submitting the Student's Household Information Sheet. Please be aware that the Student's Household Information Sheet is not the same document as a Certificate of Residency.
- Please ensure to make one application per child in the case that you have more than one child currently attending elementary and/or junior high school.
 - An original copy of the Habitant and Inhabitant Tax Exemption Certificate must be submitted for the first child's application. However, a photocopy will suffice for any further applications of successive children.
- * For application submitted in April and May, submission of tax certificates from the previous fiscal year is required. Tax certificates from the current fiscal year are required for applications submitted in or after June.
